School Nutrition- providing meals for all families; in addition, supplying breakfast bars in the event someone comes hungry; Is there something we missed? P: raised \$2,000 with carnivals- can't gather in large groups; is there money in the budget to supplement that-sites have been given additional funds for an educational purpose; one school club reached out and asked if needs for families- field trips are on hiatus- supply costs are more due to 1:1 purchase and not groups due to sharing; P: how will information be disseminated to parents?
