A description of how students will be identified and the needs of students will be assessed.

Redding School District will extend instructional time to support targeted students in an additional summer learning program and create an opportunity for targeted students to participate in an early start program a few weeks before the school year begins for the school years 2020/2021 and 2021/2022. Local assessments will be disaggregated in order to identify those students who need extra time to increase academic outcomes. From those identified students, priority will be given to Foster Youth, Homeless, English Learners, and Socioeconomically Disadvantaged students. Based on local achievement data, K-5 will focus on English Language Arts and Literacy and grades 6-8 will focus on math. The District will offer Summer School to increase the time for learning for identified students. Bussing will be provided for students in order to increase access to the summer school program. An early start, consisting of students receiving academic and emotional support for a few weeks to a day before the school year starts that will assist students in a successful transition into the new school year. In addition, students will be provided additional support throughout the school year with targeted small group instruction based on academic and/ or emotional need. During the school year, students will also be supported extra support in the area of work completion.

Redding School District will continue to close learning gaps through the implementation, expansion and enhancement of learning supports. During the school year, additional and/or existing staff will provide students extra support in the area of work completion and tutoring. District Schools and classrooms will increase access to digital and printed materials for students in order to increase and expand engagement in reading. Additional instructional materials will also be provided in order to increase the academic and social emotional outcomes of all.

Integrated student supports that address barriers to learning will be implemented via technology coaches and technology supplies. Learning hubs will be supported through the provision of Wifi Hotspots, digital devices, and educational software, such as Zoom and Kami.

Additional academic services for students will be provided through after school childcare support in the summer months of 2020/2021 and 2021/2022. Additional provision to students will include support for Home School and a middle school opportunity class to best meet the needs of students.

Training will be provided in order to meet the needs of students academic and social emotional needs followed by coaching of learned research and evidence based strategies.

Parents will be notified of this additional opportunity via the site administrator in a newsletter, letter, and school messaging platform. The site administrator will share this opportunity via the school communication tool and/or a letter.

A description of the LEA's plan to provide supplemental instruction and support.

K-8 students will be provided an engaging environment for the purpose of additional instruction. In grades 1st-5th, the focus will be around English Language Arts and Literacy. In grades 6-8, the focus will be around priority math standards, with a targeted focus on Expressions and Equations. To measure growth, Trimester 3 data will be used as a baseline. At the end of the four week program, grades 1st and 2nd will be assessed using the Basic Phonics Skills Test and High Frequency Words. For grades 3-5, Renaissance Place will be used to measure

growth. For grades 6-8 an entrance and exit quiz on Expressions and Equations will be used to measure growth. Identified students will also be provided the opportunity to attend an Early Start program before the school year begins in order to increase the engagement, emotional support, and achievement of targeted students. Additional tutoring will be provided during the 2020/2021 and 2021/2022 school year for students to achieve benchmarks.

A description of how ELO Grant funds are being coordinated with other federal Elementary and Secondary School Emergency Relief Funds received by the LEA.

The District intends to use the Expanded Learning Opportunity (ELO) Grant funds as intended to address learning loss for the remainder of the 2020/21 school year and throughout the 2021/22 school year. The District is planning to use the Elementary and Secondary School Emergency Relief (ESSER) funds concurrently with the ELO funds primarily to support the activities provided in this plan in the form of maintaining a clean, safe and functional environment. In addition, the ESSER funds will ensure continuity of services as well as mitigating operational impacts due to the COVID-19 Pandemic.

Expanded Learning Opportunities Grant Plan Instructions: Introduction

Instructions: Plan Requirements

An LEA receiving ELO Grant funds under *EC* Section 43521(b) is required to implement a learning recovery program that, at a minimum, provides supplemental instruction, support for social and emotional well-being, and, to the maximum extent permissible under the guidelines of the United States Department of Agriculture, meals and snacks to, at a minimum, students who are included in one or more of the following groups:

- low-income,
- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and
- students who are below grade level, including, but not limited to, those who did not enroll in kindergarten in the 2020–21 school year, credit-deficient students, high school students at risk of not graduating, and other students identified by certificated staff.

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.
- "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the

supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (*EC* Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, *EC* Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.

• An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
