3. Review Draft LCAP

a. Cindy Bishop did an overview of the draft LCAP for Redding School District (Shasta and Igo have their own LCAP, which are primarily the

- Goals have not changed briefly discussed the successes, such as a decrease in district-wide suspension rate

 - i. Action 1:10 Math Adoption Cycle State Board of Education has pushed out the adoption date for two years
 - ii. Acton 1:16 Math Committee To address the drop in math scores implemented math fact fluency take home bags
 - iii. New Action 1:18 To support positive outcomes as the District has been identified for Differentiated Assistance and Compliance Improvement Monitoring by the State board of Education
 - iv. New Action 1:19 Will support meeting the needs of the District's youngest learners with more early learning opportunities
- g. Goal #2 Curriculum with well-rounder pathways
 - i. Emily asked about the Healthy Kids Survey
 - 1. Cindy explained that the survey is completed by students in fifth & seventh grade and then once again in High School. Fifth grade students have a permission slip that needs to be returned authorizing them to take the survey, and seventh grader parents can opt their child out of completing the survey. There are many survey questions but only a few answers are pulled out, and reported in the LCAP. The survey is part of the Tobacco-Use Prevention Education (TUPE) Program. Kim Miller has her 4th/5th/6th/7th & 8th grader participate due to being such a small site to get more participation.
