## **Juniper School**

- 6. Parent club
- 7. Classroom volunteers
- 8. Special projects
- 9. Annual meet the teacher
- 10. Coffee with the principal

The school convenes an annual meeting to inform parents about Title I, Part A requirements and about the right of parents to be involved in the Title I, Part A program (ESSA Section 1116[c][1]).

- 1. An annual meet the teacher, held the day before school starts,
- 2. Principal asks for nominations for the first Site Council meeting.
- 3. Back to School Night announcement is made in regards to Title 1.
- 4. Back to School night asking for nominations. To be held via ZOOM 20/21

The school offers a flexible number of meetings for Title I, Part A parents, such as meetings in the morning or evening (ESSA Section 1116[c][2]). Meetings are held at the convenience of the Site Council Board.

- 1. Chairperson coordinates with the principal what times work best for all on the council
- 2. Meeting dates and times are discussed after the first set Site Council meeting of the year. Dates may be established at the end of each Site Council meeting.

### 2. Student Study Teams are held upon parent request

The school coordinates and integrates the Title I, Part A parental involvement program with other programs, and conducts other activities, such as parent resource centers, to encourage and support parents in more fully participating in the education of their children (ESSA Section 1116[e][4]).

- 1. Parent engagement nights are held several times a year
- 2. School assemblies are held each trimester
- 3. A parent assembly/dessert is provided by Parent Club for participating/volunteering.
